Your certificate of attendance must be provided to MHP within one year of your loan closing date to comply with the requirements of the ONE Mortgage Program. A HomeSafe representative will be contacting you on or before the one-year anniversary of your closing to confirm your enrollment and attendance in a HomeSafe workshop.
